Sub.- Violation of provision of Mineral Conservation and Development Rules, 2017 (MCDR'2017) in respect of your Agnashini Limeshell Mine (ML No.2667) over an extent of 4.85 Ha. situated in Gokarn Village, Uttar Kannada District of Karnataka State.

महोदय/Sir,

The following provisions of Mineral Conservation and Development Rules, 2017 were found violated in respect of your above mine during the inspection on **22/05/2024** by Shri. Vidyadhar V. Tari, Asstt. Mining Engineer of this office in your presence.

Rule No.	Nature of Violations observed
11(1)	Mining operation has not been carried out in accordance with Review and Updation of Mining Plan (RMP) approved vide this office letter no. RMP/MAN-03(KNT)/GOA/2021-22 dated 07.12.2021 to the extent indicated as below: - During 2022-23, it was proposed to produce 20,408 tonnes of Limeshell. However, as per the monthly returns submitted to this office production of 50 tonnes of Limeshell has been carried out during 2022-23, thereby achieving only 0.25% of the targeted Limeshell production.
55(1)(3)	Mining Engineer and Geologist required under the said rule are not appointed.

02. In this connection, it is brought to your notice that the above violations constitute an offence punishable under Rule 62 of Mineral Conservations and Development Rules (Amendment), 2021 notified dated 03.11.2021.
03. The mining operations can be suspended under rule 11(2) if compliance of rule 11(1) is not found satisfactory.
04. You are advised to rectify the above violations immediately and intimate the position to this office within 45 (Forty-Five) days from the date of issue of this letter.
