**विषय/Sub:** Violation of provisions of Mineral Conservation and Development Rules, 2017, in respect to your erstwhile Umba Limestone mine (7.69 hectare) Mine Code 38GUJ08132 in District Gir-Somnath of Gujarat State.

महोदय/Sir,

The undersigned has inspected your aforesaid erstwhile mine in the presence of the Mr. Satish Trivedi, nominated owner and other Government officials on 18.09.2024 as the mining lease was going to expire on 22/09/2024. Following provisions of MCDR 2017 were found violated in your mines and the same has been communicated to you vide letter of even number dated 20.09.2024.

21(2)	The holder of a mining lease shall send to the authorised officer, as the case may be, a notice in Form D of the Schedule of his intention to abandon a mine so as to reach them at least ninety days before the intended date of such abandonment, which shall be accompanied by plans and sections on a scale as specified in rule 31 setting forth accurately the work done in the mine up to the time of submission of the notice including the measures envisaged for the protection of the abandoned mine or part thereof, the approaches thereto and the environment. In your case, it is found that you have not submitted the Form D along with requisite plans and sections etc.
21(4)	The holder of a mining lease shall not abandon a mine unless a final mine closure plan duly approved by the competent authority, is implemented, and for this purpose, the lessee shall be required to obtain a certificate from the authorised officer, as the case may be, to the effect that protective, reclamation and rehabilitation work in accordance with the final mine closure plan or with such modifications as approved by the competent authority have been carried out before abandonment of mine. In your case, the proposals of approved Final Mine Closure Plan have not found implemented.

26(1)	<p>The holder of a mining lease shall have the responsibility to ensure that the protective measures including reclamation and rehabilitation works have been carried out in accordance with the approved mine closure plan or with such modifications as approved by the competent authority but in your case the proposals of FMCP have not been implemented mainly to the following extent;</p> <p>(i) According to point No. 5.2 of the approved final mine closure plan, it was proposed to plant 800 No. plants during the year 2024-25 (22.09.2024) but at the time of inspection it was found that proposed plantation has not been carried out.</p> <p>(ii) According to point No. 5.2 of the approved final mine closure plan, it was proposed to carry out 2314 m barbed wire-fencing around pit &amp; plantation during the year 2024-25 (22.09.2024) but at the time of inspection it was found that proposed fencing has not been carried out.</p>

3. In this connection, it is brought to your kind notice that the above violations constitute an offence punishable under Rule 62 of MCDR 2017, and
4. You are advised to rectify the above violations immediately and intimate the compliance position to this office within 30 days from date of issue of this letter.
5. You are therefore directed to show cause within a period of thirty (30) days from the date of issue of this letter, as to why you should not be prosecuted and/or why not any other appropriate action(s) can be initiated in accordance with rules and/or any competent orders/directives.
6. Please note that no further notice will be given to you in this regard.
7. This letter is being issued with the approval of Regional Controller of Mines.
