Sir, The following provisions of the Mineral Conservation and Development Rules, 2017 were found violated in your above mine during the inspection carried out by undersigned on 19/09/2025 in presence of Mine Officials.

In this connection, it is brought to your notice that the above violations constitute an offence punishable under Rule 62 of the MCDR, 2017. In case of non-compliance with the aforesaid rules of the MCDR, 2017, the following action may be initiated against you under the provisions of the MCDR, 2017: (i) All operations of your mine may be suspended. (ii) Prosecution may be initiated against you. (iii) Recommendation for termination of the mining lease to the State Government. 3. You are advised to rectify the violation of Rule 11(1) of the MCDR, 2017 at the earliest and to inform this office about the compliance status within forty-five (45) days from the date of issue of this letter. 4. The violation pointed out above under Rule 45(7) of the MCDR, 2017 shall be treated as a show-cause notice, and you are hereby granted 30 days' time to rectify the same. 5. Therefore, you are directed to show cause within thirty (30) days from the date of issue of this letter/notice as to why action under Rule 45(7) and Rule 62 of the MCDR, 2017 should not be initiated against you. 6. Please note that no further notice will be issued to you for violation of Rule 45(7) of the MCDR, 2017. In case of noncompliance, the provisions of Schedule-II under Rule 45(7A) of the MCDR, 2017 shall be applicable. Copy for kind information to: 1. Controller of Mines (NZ), Udaipur. 2.
