Sir, The following provisions of the Mineral Conservation and Development Rules, 2017
were found violated in your above mine during the inspection carried out by undersigned
on 30/07/2025 in presence of Mine Officials.

In this context, your attention is drawn that violation of the above rules is a punishable offense under Rule 62 of Mineral Conservation and Development Rules, 2017 and non-compliance of the above rules is punishable under Mineral Conservation and Development Rules, 2017: i) All operations at your mine may be suspended. ii) Prosecution may be initiated against you. iii) Termination of mining lease may be recommended. You are, therefore, directed to rectify the above violation at the earliest and inform this office about the status of rectification within 45 (forty five) days from the date of issue of this letter.
